THE YORK WATER COMPANY DECLARES 594th DIVIDEND

York, Pennsylvania, May 7, 2019: The York Water Company's (NASDAQ:YORW) President and CEO, Jeffrey R. Hines, announced today that the Board of Directors at their May 6th meeting declared a quarterly dividend of \$0.1733 per share. The dividend is payable July 15, 2019 to shareholders as of record date June 28, 2019.

This is the 594th consecutive dividend to be paid by The York Water Company. York Water, which is the oldest publicly traded company in the nation, has never missed a dividend in over 200 years. This is believed to be the longest record of consecutive dividends in America.
