## THE YORK WATER COMPANY DECLARES 590<sup>th</sup> DIVIDEND

**York, Pennsylvania, May 8, 2018:** The York Water Company's (NASDAQ:YORW) President and CEO, Jeffrey R. Hines, announced today that the Board of Directors at their May 7<sup>th</sup> meeting declared a quarterly dividend of \$0.1666 per share. The dividend is payable July 16, 2018 to shareholders as of record date June 29, 2018.

This is the 590<sup>th</sup> consecutive dividend to be paid by The York Water Company. York Water, which is the oldest publicly traded company in the nation, has never missed a dividend in over 200 years. This is believed to be the longest record of consecutive dividends in America.
