## THE YORK WATER COMPANY ANNOUNCES 559<sup>th</sup> CONSECUTIVE DIVIDEND OVER 194 CONSECUTIVE YEARS

**York, Pennsylvania, August 27, 2010:** The York Water Company's (NASDAQ:YORW) President and CEO, Jeffrey R. Hines, announced that the Board of Directors at their August 23<sup>rd</sup> meeting declared a quarterly dividend that maintains the rate of \$0.128 per share.

This is the 559<sup>th</sup> consecutive dividend paid by The York Water Company. York Water, which is the oldest investor owned utility in the nation, has paid dividends for 194 consecutive years beginning in 1816. This is believed to be the longest record of consecutive dividends in America. The dividend is payable October 15, 2010 to shareholders as of record date September 30, 2010.
