THE YORK WATER COMPANY ANNOUNCES 575th DIVIDEND

York, Pennsylvania, August 19, 2014: The York Water Company's (NASDAQ:YORW) President and CEO, Jeffrey R. Hines, announced that the Board of Directors at their August 18th meeting declared a quarterly dividend of \$0.1431 per share.

This is the 575th consecutive dividend paid by The York Water Company. York Water, which is the oldest investor owned utility in the nation, has paid dividends for 199 consecutive years beginning in 1816. This is believed to be the longest record of consecutive dividends in America. The dividend is payable October 15, 2014 to shareholders as of record date September 30, 2014.
